4. Set up my display so as to leave sidewalk space for the passage of pedestrians, wheelchairs, or any other handicap equipment.
5. No use of any alcoholic beverages on the Town's public property.
6. Overnight security will not be provided
7. **Abide by the designated hours scheduled for the event (8am-2pm) and will have all unsold items or Food Vendor Trailers and rented space cleared by 2:45 pm due to re-opening of Cleveland Street at 3pm NO EXCEPTIONS.**
